

- Honor Donor Intent While Being Able to Change Over Time


CNYCF Statistics

- Founded in 1927
- >\$200m+ in total assets at January 2017
- > 700+ charitable funds under administration
 - Funds ranging in size: \$10k \$20m+
 - Each fund with a donor-defined mission and purpose
- >\$150m+ in grants since inception
- > 2,000+ grants totaling \$11m+ to 900 charities
 - 50% of grants Donor Advised, 25% Board Discretionary,
 25% Designated, Scholarship and Other
- ➤ Focus on Onondaga and Madison Counties
 - Plus: Cayuga, Cortland and Oswego









Nonprofit Organization Impact Strategies

Current Collective Impact Priorities



Rosamond Gifford 1873-1953


Bequest established the Rosamond Gifford Charitable Corporation in 1954

Started with endowment of \$5.5 million

"Do good with my money."

Initial board was her advisors (lawyer, banker, etc.)

Since 1954 given over \$43 million in grants




